The budget division, which is a part of the department of the economic affairs prepares the budget after the planning commission and finance ministry issue the spending guidelines "Ministries prepare their demands based on these guidelines. Once it is passed by the parliament, the president

signs if into an act.







More than 100 participants joined this activity which revolved around Balaji Wafers' automated plant in Rajkot.




