

Fellow Program in Management (FPM) Conduct & Admission Procedure

Admission Eligibility of Students

- a. Qualifications:
- Master's degree or equivalent in fields like Engineering, Technology, Management, Economics, Social Science, Biological Science, Pure Science, Commerce, or Humanities with a First-Class standing.
- b. Final Examination Candidates:
- Students appearing for their final examination can apply and be provisionally admitted if they complete their Master's degree requirements before 30th September of the admission year.
- They must submit their final year mark sheet by 31st December to confirm eligibility.

Admission Procedure

a. Admission Timing:

• Admissions are typically aligned with the AICTE approved Post Graduate Diploma in Management or equivalent programs, with advertisements made simultaneously.

Research Guidance

a. Eligibility of Guides:

- Faculty members with a Ph.D. and at least two recent publications in high-quality journals are eligible to guide candidates. Each can guide a maximum of two candidates per admission year.
- b. Absence and Change of Guide:
- In case of the guide's absence for over a year, a new guide is nominated. If the absence is under two years, the previous guide acts as a co-guide upon return. Guides absent for over two years are replaced.
- Changing a guide is allowed under exceptional circumstances with the Director's recommendation.
- c. Number of Research Fellows:
- A guide can supervise up to five research fellows at any given time.
- d. Research Advisory Committee:
- The Director nominates this committee based on the guide's recommendation.

Course Study/ Credit Requirements

a. Credit Requirements:

- A minimum number of course credits must be earned as part of the Fellow Programme.
- b. Courses and Seminars:
- Courses and seminars are decided by the candidate's guide(s) and the Research Advisory Committee, with Director's approval.
- c. Duration for Earning Credits:
 - Credits must be earned within three years of admission, extendable by one year with progress reviews every six months.

d. Credit Course Structure:

- Module 1:
 - FP01 Research Methodology (3 credits)
 - FP02 Managerial Statistics (3 credits)
 - FP03 General Management (3 credits)
 - FP04 System Approach to Management (3 credits)
- Module 2:
 - FP05 Three stream-specific courses (3 credits each, total 9 credits)
 - FP06 Credit Seminar (General) (3 credits)
- Module 3:
 - FP07 Credit Seminar (Specific) (3 credits)
 - FP08 Review paper based on thesis-related literature (3 credits)
 - Total Credits: 30
- e. Grading System:
- A minimum CGPA of 6.5 on a 10-point scale or 60% is required to pass. Candidates failing to achieve this must repeat the course/seminar. Failure upon repeating results in termination from the program.

Registration Seminar and Progress Seminar

- a. Pre-registration Seminar:
- Conducted after completing the three modules, this seminar involves the guide(s), faculty experts, and the Director. The research scholar submits a 15-20 page pre-registration report outlining the thesis title, research framework, objectives, scope, hypotheses, & methodology.
- If unsuccessful, candidates can modify and resubmit their proposals for a second seminar. Failure again results in termination from the program.

b. Formal Registration:

- Candidates must apply for formal registration within one month after successfully completing the pre-registration seminar.
- Duration of the Programme

a. Minimum and Maximum Duration:

• The minimum period for thesis submission is 2 years, and the maximum is 5 years. Authorized breaks or leaves of absence are not counted towards the minimum duration but are included in the maximum duration.

Submission and Evaluation of the Synopsis and Thesis

- a. Pre-Synopsis Seminar:
 - Before thesis submission, a pre-synopsis seminar is conducted. The candidate submits five copies of the pre-synopsis report, including a summary of the thesis, methodology, results, analysis, conclusions, limitations, and future research scope.
 - The seminar is evaluated by a committee including the Director, guide(s), two faculty experts, and an external expert. The committee suggests modifications, and an abridged version of the report (15-70 pages) is submitted as the synopsis.
- b. Synopsis Submission: (Instruction as per AICTE)
- c. Selection of Examiners: (Instruction as per AICTE)
- d. Thesis Submission: (Instruction as per AICTE)
- e. Examiners' Recommendations: (Instruction as per AICTE)
